#### Super Saturday?

We were so excited to have a great day filled with contests, however, this will have to be postponed for now. Those few contests that qualify for State conference in June will have updates soon so that youth can schedule in appointments to come into the office and compete with a limited group of individuals. We are looking at options to run all other contests later this summer, perhaps with Rocket Fly day as well!

#### **MQA Training?**

As of right now, and again, things are changing by the hour, we are planning on holding MQA training. The schedule will be changed and will now run over the span of four days to ensure we can get everyone certified. Wednesday April 22nd through Saturday April 25th. New RSVPs will be created and I will be working with everyone to ensure that only a small amount of youth are testing at any time and we will be fully disinfecting between testing groups.

#### Goat & Sheep Tag-In?

Don't worry, we have not forgotten about this! We are working on this in partnership with the fairgrounds and fairboard. We will be sure to send out updated instructions

just as soon as we get all the logistics sorted out!

#### FAIR?!

As of right now we have no reason to believe the Douglas County Fair will not run as planned and be as amazing as ever! We are advising families and youth to work on their projects as they normally would and focus on enjoying the process and learning as much as possible!

#### Educational Opportunities & Staying Connected?

We are hard at work across the state and in Douglas County to bring 4-H youth educational resources digitally. We will be investigating digital meetings, video workshops, interactive games, etc. We have an amazing 4-H community here in Douglas County and we want to help the youth and families stay as connected as possible through all of this! Additionally, if you know of a family in our community who does not have easy access to digital learning, please let us or your club leader know and we will work with that family directly on staying connected.

#### **Deadlines & Member in Good Standing?**

We want to focus on what 4-H is really all about: positive youth development, education, and supporting our youth. With this in mind some deadlines might be extended or changed based on current events. Similarly, with most club meetings suspended things like demos, attendance, community service, etc. become difficult. I will be working with the org leaders to figure out what makes sense for each club. Please do your best to stay active and participate in a safe and reasonable way. This can be as easy as staying in email contact with your leaders, having your youth call a fellow club member for advice on a project, participating in county wide digital activities, videoing your demo and sending to your leader, giving a talk about why community service is so important, etc.

#### **Shooting Sports Hunter Safety Card**

This deadline will be extended. We are not yet setting a final date as we do not know what is to come over the next few days and weeks. If things settle down we will aim for mid-May. The most important thing to note is while this deadline has been extended youth still cannot participate in 4-H related shooting sports activities until that card has been earned and uploaded. This rule is a state rule based around safety. More information will be coming as to county and state shoot qualifications.

So have some fun with it and share with your fellow 4-Hers!


